Mr. Templeton explained that staff reviewed all bonded projects and performed many on site construction visits and he believes that all projects are compliant with bond covenants. Mr. Meierhenry updated the Board on the IRS audit of the Series 2007 bonds and explained that he would keep the Board updated on it.
