A quorum was declared by the Chairman and the meeting was called to order.

Mr. Don Templeton advised the Authority members that the notice of the meeting dated June 6, 2018 had been posted at the South Dakota Building Authority doors, on the state website and the Authority's website prior to the meeting and is on file at the Authority office.

Mr. Templeton asked if any member had a conflict of interest and none were noted.

The Chairman asked for consideration of the minutes for the October 5, 2017 annual meeting. Mr. James Roby moved to approve the minutes. ## SDSU & USD Bonding

Mr. Templeton explained that the state legislators approved two new projects to be bonded: Precision Agriculture at South Dakota State University and the Dakota Dome remodel at the University of South Dakota.

## Fiscal Year 2019 Operating Budget

The Chairman stated the next order of business would be to consider the fiscal year 2019 operating budget for the South Dakota Building Authority on file at the South Dakota Building Authority Office. Mr. Christopherson reviewed the South Dakota Building Authority revenues and expenses and cash balances. He

explained that \$147,217 of South Dakota Building Authority funds were transferred to the state in fiscal year 2018.

After further discussion, it was moved by Mr. Jim Breckenridge to approve the fiscal year 2019 operating budget, a copy of which is on file at the Authority office. The motion was seconded by Ms. Tina Van Camp and upon the roll call, the ayes were: Breckenridge, Graham, Hajek, Neugebauer, Roby, Van Camp and Zellmer; nays: none; abstain: none. Motion carried.

#### **Contracts**

Mr. Templeton reviewed the South Dakota Health and Educational Facilities Authority (SDHEFA) contract with the South Dakota Building Authority (SDBA) for fiscal year 2019 at a monthly rate of \$14,783.03 for personal services, office space and utilities. Chairman Graham commented that the shared management services of the SDHEFA and SDBA has worked out fine and that all the staff has done a great job. The Eide Bailly rebate computation contract for calendar year 2018, on file at the Authority office, was reviewed in detail. Mr. Don Templeton and Mr. Todd Meierhenry reviewed the Meierhenry Sargent contract, which is on file at the Authority office. Mr. Doug Hajek moved to approve the Meierhenry Sargent LLP calendar year 2018 contract to provide legal services. The motion was seconded by Mr. Dennis Neugebauer and upon the roll call, the ayes were Graham, Breckenridge, Hajek, Neugebauer, Roby, Van Camp and Zellmer; nays: none; abstain: none.
