A quorum was declared by the Chairman and the meeting was called to order.

Mr. Templeton advised the Authority members that the notice of the meeting dated June 7, 2019 had been posted at the South Dakota Building Authority doors, on the state website and the Authority's website prior to the meeting and is on file at the Authority office.

Mr. Graham asked if any member had a conflict of interest and none were noted.

Mr. Graham asked if any members of the public were in attendance and none were noted.

The Chairman asked for consideration of the minutes for the May 14, 2019 special meeting. Mr. Hajek moved to approve the minutes. Fiscal Year 2020 Operating Budget

The Chairman stated the next order of business would be to consider the fiscal year 2020 operating budget for the South Dakota Building Authority on file at the South Dakota Building Authority Office. Mr. Christopherson reviewed the South Dakota Building Authority revenues and expenses and cash balances. The revenues over expenses are \$119,337. He explained that \$237,491 of South Dakota Building Authority funds were transferred to the state in fiscal year 2019.

After further discussion, it was moved by Mr. Breckenridge to approve the fiscal year 2020 operating budget, a copy of which is on file at the Authority office. Contracts

Mr. Christopherson reviewed the South Dakota Health and Educational Facilities Authority (SDHEFA) contract with the South Dakota Building Authority (SDBA) for fiscal year 2020 at a monthly rate of \$15,346.78 for personal services, office space and utilities. The Eide Bailly rebate computation contract for calendar year 2019, on file at the Authority office, was reviewed in detail. Mr. Christopherson and Mr. Meierhenry reviewed the Meierhenry Sargent contract, which is on file at the Authority office. Ms. Van Camp moved to approve the Meierhenry Sargent LLP calendar year 2019 contract to provide legal services. The motion was seconded by Mr. Breckenridge and upon the roll call, the ayes were: Breckenridge, Graham, Hajek, Lust and Van Camp; nays: none; abstain: none.
