### MINUTES OF THE ANNUAL MEETING

A quorum was declared by the Chairman and the meeting was called to order.

Mr. Don Templeton advised the Authority members that the notice of the meeting had been posted at the entrance of the office of the South Dakota Building Authority on September 20, 2013.

The Chairman asked for consideration of the minutes for the June 27, 2013 meeting. Mr. Haan moved to approve the minutes of the meeting as presented, seconded by Mr. Hajek. All members present voted aye. Motion carried.

### **Election of Officers**

The Chairman stated the next order of business would be the annual election of officers for the Authority. The officer's positions being considered would be Vice Chairman and Secretary. It was noted that the Chairman is appointed by the Governor.

Mr. Lien moved to keep the officers the same, seconded by Mr. Hajek; all members present voted aye, motion carried.

# **Project Reports**

Mr. Templeton reviewed the project reports of outstanding cash balances for all bond issues with Project Fund cash balances. Mr. Templeton reviewed the August 31, 2013 financial report for the Building Authority.

### **Post Compliance**

Mr. Templeton and Mr. Meierhenry explained that staff reviewed all bonded projects and performed many on site construction visits and he believes all projects are compliant with bond covenants.

The SDBA board members scheduled a post issue compliance review of three buildings of the University Center – Sioux Falls on September 27, 2013. Tours were given for the Board Members and compliance results were recorded in our post issue worksheet.

# Release of Property

Mr. Todd Meierhenry reviewed Resolution 2-SDBA-13 (see Attachment #2) which releases property back to the State of South Dakota relating to the Series 1991B SLB bonds which have been paid in full. The properties are in Pierre, Springfield and Spearfish.

# Upcoming bond issue

Mr. Templeton reviewed the list of projects that the SDBA is working for financing. He noted that the Board of Regents chose BMO Capital Markets as the investment banker for this bond issue. The Veteran's Home may be a private bank placement. The Dept. of Game, Fish & Parks bonds will be taxable.
