### MINUTES OF THE ANNUAL MEETING

A quorum was declared by the Chairman and the meeting was called to order.

Chairman Graham asked if any members of the general public wished to speak. No members of the general public were in attendance.

Mr. Don Templeton advised the Authority members that the notice of the meeting had been posted at the entrance of the office of the South Dakota Building Authority on August 13, 2021. A copy of that notice is on file at the Authority office and is posted on the Authority & State Board & Commission website.

The Chairman asked for consideration of the minutes for the June 21, 2021 meeting. Mr. Zellmer moved to approve the retention of Mr. Hajek as the vice chair and Ms. Van Camp as the secretary, seconded by Mr. Lust; and upon roll call, the ayes were: Bartling, Graham, Hajek, Lust, Van Camp and Zellmer; nays: none; abstain: none. Motion carried.

### **Post Issuance Compliance**

Mr. Templeton and Mr. Meierhenry discussed the post issuance compliance log and explained the responsibilities of the South Dakota Building Authority relating to post issuance compliance.

#### **Project Reports**

Mr. Jost reviewed the project reports of outstanding cash balances for all bond issues with Project Fund cash balances. Mr. Christopherson reviewed the August 31, 2021 financial report for the South Dakota Building Authority. It was noted that the South Dakota Building Authority transferred \$102,455 of Administrative Funds back to the State in July of 2021. Mr. Templeton explained that Property Insurance is increasing significantly in CY-22; Risk Management is negotiating a new price to replace the expired rate.
