A quorum was declared by the Chairman and the meeting was called to order.

Mr. Don Templeton advised the Authority members that the notice of the meeting had been posted at the entrance of the office of the South Dakota Building Authority on September 19, 2014. A copy of that notice is attached hereto and is an integral part of the minutes (see Attachment #1).

The Chairman asked for consideration of the minutes for the August 5, 2014 meeting. Mr. Roby moved to approve the minutes of the meeting as presented, seconded by Mr. Mertens. All members present voted aye. Motion carried.

Mr. Templeton noted that the sale of the Series 2014 B & C bonds produced an upfront savings of \$719,061 which was given to the State General Fund.

Election of Officers

The Chairman stated the next order of business would be the annual election of officers for the Authority. The officer's positions being considered would be Vice Chairman and Secretary. It was noted that the Chairman is appointed by the Governor.

Mr. Roby moved to keep the officers the same; Vice-Chairman Doug Hajek and Secretary D.J. Mertens, seconded by Mr. Breckenridge; all members present voted aye, motion carried.

Project Reports

Mr. Templeton reviewed the project reports of outstanding cash balances for all bond issues with Project Fund cash balances. Mr. Templeton reviewed the August 31, 2014 financial report for the Building Authority.

Post Compliance

Mr. Templeton and Mr. Meierhenry explained that staff reviewed all bonded projects and performed many on site construction visits and he believes all projects are compliant with bond covenants.

The SDBA board members conducted a post issuance compliance review and tour of two buildings, the Paleontology building and the Chemistry/Biology building, at the South Dakota School of Mines and Technology in Rapid City on September 24, 2014.

Trustee Fee Schedule

Mr. Bert Olson presented a new proposed Trustee Fee Schedule (on file at the Authority office), which would reduce the fees. After a thorough discussion a motion was made by Mr. Roby to approve the Trustee Fee Schedule, seconded by Mr. Mertens. Upon roll call, the ayes were Breckenridge, Graham, Hajek, Mertens, Neugebauer, Roby and Zellmer. Nays: none and abstains: none.

Adjournment

The Chairman stated that there being no further business at this meeting, the meeting would be adjourned at 4:18 p.m. MDT.
